**State Dental P.G. Seats (MDS) Allotments-2022**

In continuation of earlier notification dated 17.09.2022, and subsequent notification(s), round 2 (off-line) allotment procedure for MDS course for Rajasthan State registered candidates, will be carried out off-line as per the schedule given below:

**Schedule for Allotment process (Round 2)**

Publishing of provisional seat matrix after round 1	14.10.2022
<b>On-line Application form filling for candidates who have not registered earlier</b> Start date for filling of on-line application form and deposition of <b>required application fee</b> Those who are already registered/have applied need not register/apply again. It is a mandatory step for subsequent process of registration and allotment. Both the parts (Part 1 and Part 2) of the application form must be filled and completed. Candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may also complete the same.	From 12.10.2022
Last date for deposition of the application fee, on-line, by candidates who have not deposited it earlier	Upto 16.10.2022, 5.00 pm
Last date for submitting the on-line application form at the website	16.10.2022 11.45 pm
Publishing of provisional Merit list and seat matrix (for off-line round 2)	19.10.2022
Verification, Allotment and Joining by Sr. Demonstrator candidates for In-Service Quota (sub quota), (before the Board, 8.00 am sharp at RUHS College of Dental Sciences (GDC), Subhash Nagar, Behind T.B. Hospital, Jaipur) (after registering as per the procedure)	29.10.2022
Physical reporting and Seat allotment at the spot on the same day along with submission of all original documents before the Board <b>at the venue RUHS College of Dental Sciences (GDC), Subhash Nagar, Behind T.B. Hospital, Jaipur</b> <b>Refer date wise, time wise and merit wise slots list to be made available at the website</b>	29.10.2022
Joining, document checking and verification (including prescribed eligibility criteria) <b>at the allotted college</b> along with printout of allotment letter, deposition of fee prescribed one year tuition fee by the college, required bonds etc. and other documents as listed in instruction booklet	Upto 02.11.2022
Further Processes	To be published later

1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. All candidates are required to deposit non-refundable application fee of Rs. 3000/- (Rs. 1500/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.
3. All registered candidates who wish to participate in round 2 off-line counseling must present themselves personally before the Board on the stipulated date and time. **To participate, print 'Entry Ticket' through candidate's login and carry the same.**
4. **Submission of original documents:** All candidates who wish to participate in round 2 off-line counseling must bring all the original documents and undertaking (as given in the instruction booklet available at the website) and accepted resignation from the institution he/she is pursuing studies at present (if any) or from the college allotted through any other counseling including All India PG counseling (if any). Failure to do so will result in disqualification for admission.

In round 2 off-line counseling, a candidate who gets fresh allotment shall deposit his/her original document alongwith undertaking.

**Note: A candidate who was allotted a seat in Round 1 by this Board and has joined the seat (and is continuing on the seat) is required to bring only Fee Receipt issued by the allotted institution while participating in round 2 off-line counseling.**

5. **Resignation:** Last date for submitting Resignation at the round 1 allotted college is **18.10.2022 by 4.00 pm.** After this, resignation, if any, shall be accepted only at the spot on candidate's merit-cum-roster point at the time of physical round 2 allotment.

Joined candidate of round 1 allotments who does not get up-graded and does not get seat of his/her choice during second round (off-line) counseling, may resign at the spot at his/her merit point without forfeiture of Registration Fee, failing which he will be considered as a joined candidate for round 2 and rules will apply accordingly.

**After round 2 allotment on merit-cum-roster point of the candidate, no resignation shall be accepted even if the candidate gets the same seat (allotted in round 1) OR gets upgraded / allotted a fresh seat in round 2. It is clarified that no resignation will be accepted (from both round 1 as well as round 2 allotted candidates) after passing over of the 'candidate's merit-cum-roster point'.**

6. The selected candidates will have to join at the allotted college as notified in the allotment letter.
7. The candidates are advised to visit the websites regularly for registration and other relevant information.
